"Authority") and	located at

· · ·	xpressed in §4.1-101 et seq. of the Code of Virginia, ty as a market participant as defined by the Supreme fied as follows:

- 1. Pursuant to this Agreement §4.1-119(D), the Distiller is an agent of the Board for the purposes of the sale of spirits and low alcohol beverage coolers, manufactured by or for, or blended by such distiller on the licensed premises.
- 2. Upon the execution of this Addendum to the Distillery Store Agreement, the Distiller is authorized to provide spirits and low alcohol beverage coolers manufactured by or for, or blended by such licensee on the licensed premises through electronic or other orders and ship such orders to consumers and licensees in the Commonwealth in accordance with the provisions of this Addendum as an agent of the Board. HOWEVER, no such distiller shall be permitted to sell more than six (6) bottles of spirits or two (2) cases of low alcohol beverage coolers to any one consumer or licensee per month.
- 3. Bottles of spirits shipped shall have a maximum capacity no more than 1.75 liters.
- 4. The Distiller shall ensure the recipient is at least twenty-one (21) years of age; and that the recipient's name and date of birth are recorded.
- 5. The Authority will assign the Distiller a designated ABC store location as a shipping point for the Distiller's online orders.
- 6. The distiller will email the customer order data to their designated ABC store and copy the Distillery Support email prior to drop-off so that shipping labels may be prepared. The required data includes the customer's name, date of birth, phone number, Email address, shipping address, order/transaction number and order details.
- 7. The shipment of spirits or low alcohol beverage coolers pursuant to this Addendum shall be packed by the Distiller and taped closed to ensure they are sealed prior to drop-off. The Distiller must affix a sticker containing the Adult Signature Required & Contains Alcohol label requirements to each box. The order/transaction number and last name of the recipient shall be affixed to the outside of each box within each order using a permanent marker, along with the number of boxes within each order.
- 8. The Distiller will make a payment to the Authority of \$12 per box-to-be-shipped at the time the order is dropped off, to be cashiered by the ABC Employee receiving the order.
- 9. The ABC store employee will affix the correct shipping label to the order and arrange for shipping. Orders must be submitted to stores by 11am for same-day pickup by UPS. Orders received after 11am will be ready for pickup by UPS on the next business day. Orders must be dropped off by 12pm for same day

pick up by UPS. The ABC store employee will email the distiller the UPS tracking number and the distiller will email the correct tracking number to the customer for orders shipped.

- 10. The Distiller will be responsible for verifying the packed items against the shipment order, ensuring proper packaging of complete shipment orders, addressing customer order complaints, issuing necessary replacements at the distillery's expense, and responding to any additional customer service concerns related to shipped orders.
- 11. Any shipping claims for reported losses or damages related to the shipments will be filed by the Authority.
- 12. All Distillers shall report to the Authority on a monthly basis the following information:
 - 1. Whether any shipments of bottles or low alcohol beverage coolers were made during the prior month; and
 - 2. If shipments were made the following information:
 - a. Number of bottles of spirits and cases of low alcohol beverage coolers shipped;
 - b. Volume of each bottle of spirits and each low alcohol beverage coolers shipped;
- 13. This Addendum to the Distillery Store Agreement shall remain in effect until further amended, modified, or rescinded by the Authority.
- 14. The Authority may terminate this addendum and the privileges herein with or without notice for good cause shown.
- 15. All other provisions of the Distillery Store Agreement shall remain in full force and effect.
