## Licensee Limited Availability Lottery Launches April 27

Licensees in the Virginia ABC licensing system (VAL) have the opportunity to purchase limited availability products through the Licensee Limited Availability Lottery program.

These products include highly sought bourbons, whiskies and other small batch spirits offerings.

To be eligible, a license must be in active status with mixed beverage privilege and must possess a Virginia ABC MIPS account to submit an entry.
